


# **Japanese Knotweed Remediation**

Legally, landowners must have the ability to fully use their land. The presence of Japanese knotweed stops this from happening. <sup>1</sup>

True eradication requires that all knotweed rhizomes (roots) are removed. Complete excavation achieves this but is costly. Other forms of control such as herbicide treatment and soil sifting, merely controls the problem. **Is there a better solution?** 

## Our approach

A reduced dig excavation, lined both horizontally and vertically with our CuTex permeable root barrier, **makes a previously knotweed infested space fully usable**. Any remaining knotweed rhizome will not have the energy to breach the barrier and PBA will monitor until two years lapse without regrowth and then guarantee the solution.



## Implementing Knotweed remediation

**Survey and report:** Use an experienced and accredited Knotweed specialist, such as PBA to write a RPS178 compliant management plan to correctly assess and propose the best knotweed solution.

**Knotweed waste:** Assess what can happen to the knotweed impacted waste, does it have to go off site? This is COSTLY and bad for the environment. Landfill is a scarce resource and not designed for knotweed impacted waste. We offer a middle way to reduce costs.
